#### **NEW MEMBERS**

Once you hear back from us regarding your application, please send through the **Season Registration Form 2020** to <u>bookings@ripeme.com</u> at your earliest convenience.

#### HOW TO MAKE A BOOKING

All bookings should be made by email to <u>bookings@ripeme.com</u>. Please ensure all information is provided or your booking will not be completed.

If you wish to book for more than one-month, kindly note, the Ripe Market will require predated cheques for upcoming months beforehand (either before the beginning of the season or no later than 2 weeks before the first participating market).

To make a booking simply email the following information, with the booking form filled out.

#### **REGISTRATION FEE**

Annual registration fees will be applied at the beginning of the outdoor market season. The registration fee is to be paid in advance of any booking by credit or debit card, any previous outstanding balance will be settled upon registration. Prices are as follows:

One-Off Annual Participation Fee

- AED 300; Arts & Craft Vendors
- AED 550; All Food Members

#### PAYMENTS

VAT is a consumption tax that the end user is obligated to pay and Ripe Exhibitions Organizer Co LLC will be only acting as a collection agent on behalf of the taxation authority. Ripe Exhibitions Organizer Co LLC is legally obliged to comply with this Government mandate from 1st January 2018.

Ripe Market is a prepaid market; therefore, **all payments must be cleared a minimum of 3 days before** the market date. Once booking is confirmed via email, **vendor is liable to payment full amount.** 

For all Arts & Craft / Food members we can accept the following payment options: <u>Cash</u> – Please drop by our offices in the Collective by Ripe building, opposite Bounce in Al Quoz 1 to hand the amount payable over to the Bookings team.

<u>Debit or Credit Card</u> – Please complete our Market Card Payment Form on page 6 and email it to <u>bookings@ripeme.com</u>, or call our team, 04 315 7000, to pay over the phone.

Ripe Market does not accept Bank Transfers for payment. A **late payment fee of AED 75** is charged weekly from any unpaid booking.

#### CANCELLATIONS AND REFUNDS

All cancellations must be emailed to <u>bookings@ripeme.com</u>. We cannot accept any verbal cancellations at a market or over the phone.

## Arts and Craft / Food members: **full refunds** will only be provided to members who **cancel 7 days prior to the market date**.

As an example, if you are cancelling a Saturday market, we must receive an email from you before close of business the previous Saturday.

**Cancellations made between 5-7 days prior** to the date of market, will be offered **50%** of the original booking price back in credit, this can be used towards your next table booking within in the same market season.

#### Cancellations less than 5 days will not be given a refund.

#### WEATHER CONDITIONS & FORCE MAJEURE:

Outdoor Ripe Markets remain open throughout the entire winter season including all weather conditions. No refunds will be given to any members whom do not adhere to the cancellation policy regardless of weather conditions, this includes members who turn up to a market in bad weather and request a refund.

The Ripe Market team will notify any members if a market is to be cancelled in the event of expected bad weather or dangerous weather conditions.

#### SAFETY & WASTE MANAGEMENT:

All vendors must **wear hand gloves** during the market especially when transacting with a customer. Each vendor is required to provide for their own **hand sanitizer** and **'Stand Here'** sticker for their stand.

Please ensure that you do not leave your discarded packaging or rubbish at the venue. NO liquids including water/ oil/ ice to be discarded onto anywhere onsite.

AED 500 penalty charge will automatically be added to your account if you do not clean up after the event.

#### PLANTING AREA

Absolutely no items (e. g. tables/ packages/ gas canisters/ rubbish bags/ hand wash sinks/ extra stock) are to be stored/ located in/on the planting area. All items must be stored within your allocated space.

AED 500 penalty charge will automatically be added to your account if items are found in these areas.

#### BRANDING:

No flags or roll-ups are allowed. No branding of any kind can be placed on any venue property aside from the designated space. Branding without approval by the Ripe Market team will be removed.

All standalone branding must be contained within your allotted space and behind your table not in front and not blocking your neighbours stand.

Members need to bring their own tablecloths and it is recommended that they are from tabletop to ground to help hide storage boxes or personal possessions. Table dimensions: width 0.75m | height 0.80m | length 1.5m

#### MARKETING:

It is in the interest of every member that if they want their business to succeed at the Ripe Market, they must inform their existing customers and follower base about their participation at all Ripe Market's via social media platforms, company website and any other network channels to create awareness.
